#### Intended use

Mover Flexi - Maxi is a mobile device designed especially to help a bariatric patient with a disability to be moved by a caregiver over short distances and to facilitate moving the patient from one sitting area to another. Mover Flexi - Maxi provides support to the patient when standing up from a bed, toilet, chair or a wheelchair. The product is intended for patients who are able to stand, but not necessarily walk.

The serial number is located on the product label, which can be found on the inner side of the product left leg.








# **Product Display**

## First use

The Staebel Bariatric Patient Transfer is ready for use immediately after removing the packaging.

# **Product use:**

Adjust the flexible base of the Staebel Bariatric Patient Transfer with the lever and open up the two seat halves by manually pulling them on the side and pushing them upwards.





## Step by step use



#### **WARNING**

- To prevent patients from falling during accommodating always apply the brakes before using the equipment. (See Fig. 1)
- To prevent patient falls or caregiver injuries make sure that there are two caregivers present during the transfer of a patient if this is necessary according to the patient state.
- To prevent damages to the equipment always close the padded seats. (See Fig. 2)



### **Maintenance**

The product should be wiped with a duster. Approximately every two months the framework should be polished with a polishing paste. Knee and tight supports are made of a material that is easy to maintain - composition leather, tested according to DIN 54020. Such coating may be wiped with a dry or damp cloth; detergent for sensitive laundry can also be used if necessary but it should be wiped straight after it has been used (the stains should be removed as soon as possible in order to prevent the absorption in the material). Finally, the material should be cleaned with warm and clean water.

Ingrained dirt can be removed if rubbed with a cloth, moistened with alcohol (the cloth should not be wet). Cleaning agents that contain fats or oils should not be used. Similarly, solvents (like acetone) or rough cleaning agents should not be used.

# Safety and technical control

In accordance with »Medicinal Products Act« the safety and technical control should be carried out once a year.
